# 1 Purpose

Specific additional manual configuration is required in addition to the scope item activation to implement statistical sales conditions for SAP S/4HANA installed locally.

## 2 Prerequisites

The scope item *Statistical Sales Conditions* (34B) has been activated in your system.

### 2.1 Supported Deployments

The configuration guide provides the implementation content for the different SAP S/4HANA products:

- SAP S/4HANA Cloud – (CE) minimal scope and content
- SAP S/4HANA – (OP) installed locally (on-premise), full scope and content coverage

Depending on the use case/deployment option/ S/4HANA product version, you need to implement the required scope/content starting with the Public cloud chapter and proceed with the next required sections:

- For the full scope of the on premise scope & content – PC and OP are required
- For the SAP S/4HANA Cloud scope & content – CE is required; OP is not required

## 3 Configuration

The following sections describe all integration settings required for this scope item.

### 3.1 Assign Ledger Group

#### Purpose

In this activity, you assign the ledger group containing all the ledgers that the system would use to record postings for statistical sales conditions. Additionally, this also activates the creation of statistical sales conditions postings overall.

#### Procedure

1. Access the activity using the following transaction:

<i>Transaction Code</i>	<b>SM30</b>
<i>Table/View</i>	<b>FCOV_STAT_ACT</b>

2. Choose *Maintain* and enter the ledger group containing all the ledgers that the system would use to record postings for statistical sales conditions.
